**ANNEX II TO THE AGREEMENT
for the Provision of Internet (ADSL) Services**

1. GENERAL TERMS & CONDITIONS

- 1.1. Annex II to the ADSL Agreement (hereinafter referred to as Annex) serves to define the obligations of contracting parties in relation to using a fast and permanent Internet ADSL connection via BITSYU.NET (hereinafter referred to as SERVICES), which is an Internet service provided by GAMA ELECTRONICS.
- 1.2. Annex II is based on the premise of accepting and signing the Agreement for the Provision of Internet (ADSL) Services, applicable for all users and available via ADSL.BEOGRAD.COM website, of which it is an integral part.
- 1.3. The Parties have agreed that the Annex shall apply to the new accounting period, from the date of signing Annex II and making first payment under the amended terms.
- 1.4. Any changes in payment terms must be agreed on at least thirty (30) days prior to the expiration date of the current accounting period.

2. SUBJECT OF ANNEX

- 2.1. Subject of the Agreement is change in payment terms for the selected service pack.
- 2.2. Upon timely request, USER may be allowed to also change their ADSL pack, provided technical requirements are met and that all the additional fees are paid by USER.

3. COMPENSATION FEES

- 3.1. By signing Annex II, USER irrevocably declares that he chooses to subscribe in the next accounting period to the selected service pack for the duration of: 1. six (6) or 2. twelve (12) months (please circle the selected subscription).
- 3.2. Information on compensation fees for providing Internet access for the selected ADSL pack is available via ADSL.BEOGRAD.COM website.

4. USER RELOCATION

- 4.1. GAMA ELECTRONICS is not under any obligation to refund a payment in the event that, due to USER relocating to another location and/or other reason, USER is unable to use Internet (ADSL) services during the entire or part of the subscription period caused by lack of technical conditions for which GAMA ELECTRONICS is not responsible.
- 4.2. Subscription can not be transferred to a third party.

5. TERMS OF PAYMENT

- 5.1. USER agrees to pay the amount referred to in Section 3 of this Annex in the prescribed time and manner, as published on ADSL.BEOGRAD.COM website.
- 5.2. If the USER fails to pay for SERVICES in time and in the prescribed manner, GAMA ELECTRONICS will calculate the monthly service charges based on the regular prices for the selected service pack.

6. TRANSITIONAL AND FINAL PROVISIONS

- 6.1. Other provisions of the Agreement remain unchanged.
- 6.2. Annex II has been made in two (2) identical copies of which each Party keeps one (1) copy.
